It was a year of challenges and uncertainty; but once again through perseverance, ingenuity and the generous support of our donors, we were able to serve and keep that crucial connection to our Camp Sunshine community. With our mantra being that of teamwork, creativity and adaptability, we were able to bring Camp Sunshine to our Camp families through virtual technology. More aptly put, we made lemonade out of lemons.

Camp Sunshine delivered twelve programs serving 661 families. This included joining families in their homes through Zoom presentations, providing a special interactive website and sending out over 800 “Boxes of Sunshine”. Our Development Team also got very creative, rolling out initiatives that enabled families, friends and volunteers to participate and support camp in a variety of ways, such as our in-person Pumpkin Festival or through virtual events including our “Spread the Sunshine” run/walk/roll endeavor, the winter Polar dip & 5k dash and even giving people the opportunity to take part in one of our more iconic SEALS for Sunshine challenges. There was a way for everyone to join in and help.

Despite the hurdles we faced, Camp Sunshine still shined through with its high standards of service, programs and financial stewardship. Maintaining our ACA (American Camp Association) accreditation, Gold Ribbon status with COCA-I (Children’s Oncology Camp Association – International), and highest possible rating with GreatNonprofits. Equally as impressive is the fact that we earned the distinction of Charity Navigators highest 4-star rating for exhibiting sound fiscal management and transparency, as well as Guidestar’s

Gold Seal of Transparency for fiscal management.

This has been a very trying two years. But, as we plan to re-open, we embrace the thought of welcoming families and volunteers back to our beautiful campus. Families have noted their need of Camp Sunshine and the sense of belonging, along with the support they are able to get from each other as they travel along a similar path. We are humbled and honored by your generosity now and through the years. Much like the wishboats floating on the pond at the end of a camp session your commitment gives us hope for what lies ahead and buoys our resolve to steadfastly focus on our mission to serve ill children and their families.

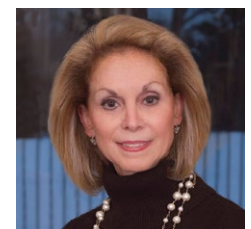

Bruce Cleland: Making a Difference!

Loving husband, dedicated father, innovator, philanthropist, humanitarian and Camp Sunshine Hero! The Camp Sunshine community as well as the world as a whole said goodbye to a very special and amazing human being this past year.

First introduced to Camp Sunshine as an attending Camp family in the 1980s, Bruce understood the value and importance of the Camp program and the comradery of coming together. Much like the close bonding of his rugby teams back in his home country of New Zealand. Having a child with Leukemia changed Bruce's perspective on life and shaped his path forward. Following his family's visit to Camp, Bruce felt the desire to help others who had received that unimaginable call echoing the message, "your child has cancer". He was acutely aware of what these families felt, were going through and the challenges they faced and he wanted to help!

Bruce embraced Camp Sunshine's mission of bringing the whole family together and took it upon himself to help ensure its success. Much like how he single handedly developed one of the most successful fundraising campaigns ever, when he founded the Leukemia & Lymphoma Society "Team in Training" charitable endurance sport initiative raising, to date, more than 1.5 billion dollars for blood cancer research, education and patient research. Bruce was also responsible for connecting Camp Sunshine to the Leukemia & Lymphoma Society and was the epitasis behind the start of that wonderful partnership.

His endeavors did not stop there, as he and his wife, Isobel "Izzy", established the Orokawa Foundation. The foundation's mission is to assist the less fortunate with housing, education and other needs.

The generosity of the Orokawa Foundation and the Cleland Family spans over many years. With Bruce and his family supporting Camp in a variety of ways, participating in matching funding initiatives to assist with land purchases and development, transportation funding, our endowment, as well as family sponsorship programs. He was also eager to share his wisdom and knowledge by serving on Camp Sunshine's Finance Committee. Those who visit our campus will see the passion that the Cleland's had for Camp in the many buildings that adorn our landscape. With Bruce at the helm the Cleland's have been instrumental in supporting the construction of our Maintenance Facility building, the Orokawa Foundation Family Volunteer Center, and most recently the Isobel & Bruce Cleland Lakefront Clubhouse.

The positive impact that Bruce has had on people and the lives he has touched are too numerous to calculate. He certainly left the world a better place, laying a blueprint of caring and unselfishness for others to follow. He will forever be a part of the fabric of Camp Sunshine and his legacy will live on through the generous acts of kindness he has left behind. As JFK once said, "As we express our gratitude, we must never forget that the highest appreciation is not to utter words, but live by them." Bruce Cleland did.

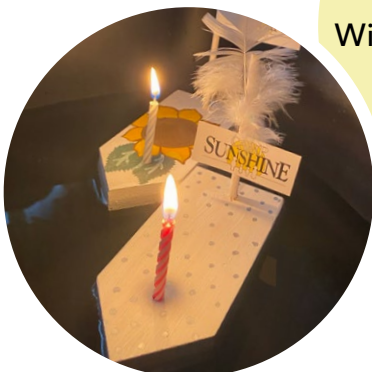

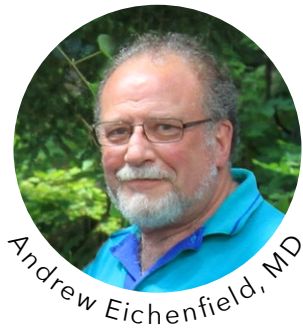
